PennDOT will follow all applicable processes for municipal and county planning collaboration, conducting environmental analysis and evaluations, design development of options including rehabilitation and replacement of the existing crossing, using established standards and guidelines, providing a safe crossing, investment of transportation funding, and public coordination.

It is the opinion of Bucks County that the proposed TIP description for the bridge repair adequately describes the importance of the location in the state park and that it is adjacent to the scenic Golden Pheasant Inn. We are well-aware of the current condition of this bridge, and that it is constrained by the geography and topography of the area. To change the scope of work in order to include bike paths would require the Borough and multiple agencies involved to redo the entire pre-construction process and risk the project losing this immediate funding opportunity.
