2a. Transportation Improvement Program (TIP) Action PA17-70: US 202, DeKalb Pike, Section 610 (Design Only), (MPMS #50364), Montgomery County

Comment/Question: I do not understand how a "decrease in travel lane widths" requires additional right-of-way, and all of the rest of the above statement indicating "increases" when it has already been done. That is simply wasteful and not acceptable.

In response to comments provided by Mr. Leonard Fritz of Kelly Engineers regarding the DVRPC's January Board Action Items with respect to the PA TIP Action:

The decrease in travel lane widths is not the cause of the additional right-of-way acquisitions. The decrease in travel lane widths is part of the mitigation strategy to reduce the impervious area and to ultimately obtain compliance with the current stormwater management regulations and requirements. If the travel lane widths were not reduced, the number of additional stormwater management best management practices (BMPs) (i.e., additional BMP basins) needed for the project would have been more, which would have resulted in substantially more right-of-way acquisitions.

The travel lane width reduction requires significant re-design of the grading, traffic control staging, signing and pavement marking, traffic signals, and drainage design which will be incorporated into the Post-Construction Stormwater Management Plan and Erosion and Sediment Pollution Control Plan as part of NPDES Permit package as well as the Plans, Specifications, and Estimates (PS&E) package.

The additional right-of-way acquisitions are required to incorporate BMP basins, drainage system revisions, and recent private development tie-ins. New guide rail and

clear zone requirements require guide rail re-design resulting in additional right-of-way acquisitions. To maintain temporary access to some properties during certain construction activities, additional temporary construction easement acquisitions are needed. H&H revisions are required due to updated design requirements and increased impervious on adjacent re-developed private properties which lead to bridge and culvert re-design and additional right-of-way acquisitions. Drainage design revisions will require additional utility coordination and relocation. The current interpretation of the ADA regulations requires re-design to incorporate additional ADA compliant curb ramps and additional sidewalk. Lastly, the majority of the additional acquisitions are for temporary construction easements to make proper driveway adjustments due to the elimination of the knock-out blocks.

Comment/Question: Comments from the Bicycle Coalition of Greater Philadelphia Bike lanes were proposed along this segment 20 years ago and we have long supported bike lanes on US 202. However, research and experience have shown that a 5-foot bike lane on a high-speed arterial road is not a treatment that will accommodate cyclists of all ages and abilities. We support bicycle facilities on this road that are physically separated from motor vehicle traffic. This could either be protected bike lanes or an off-road shared use path. This road segment has now also been designated as the preferred route for the September 11th National Memorial Trail and will partially complete a Circuit Trails connection between the Schuylkill River Trail and the US 202 Bikeway between Montgomeryville and Doylestown.

Draft response: Thank you for your comment. Your original comment was forwarded to the DVRPC Board, DVRPC Office of Capital Programs, and PennDOT.

During the planning phase for the Section 600 Corridor which started in the mid 1990's, the five- foot bike lanes next to the travel lanes were identified for inclusion (from Johnson Highway to PA 309), but not protected bike lanes or off-road shared used path (SUP). A portion of this corridor, designated as Section 65N (from Hancock Road to PA 309) through Upper & Lower Gwynedd and Montgomery Twps. was constructed and completed in late 2012. Due to the nature of the Section 600 corridor, which is a highly-developed area with building structures and commercial parking lots close to the roadway, incorporating either protected bike lanes or off-road SUP would increase property, environmental, and permitting impacts that would result in major delays to the project.

In the case of the Section 700 Corridor (202 Parkway), the inclusion of a shared-use path was identified early in the planning phase and built as part of the project. A proposed SUP along the Section 600 corridor would have to be pursued as a separate future project and discussed with local, county and regional planners.
