**Comment/Question:** Comment from the Bicycle Coalition of Greater Philadelphia There is no mention of bicycle facilities in the TIP project description. Church Rd is listed in the Camden County Master Plan as "to be considered" for bicycle facilities on this road. If bicycle facilities are not included, then we request an explanation as to why they were rejected.

**Response:** Thank you for your comment. Your comment was forwarded to the DVRPC Board, DVRPC Office of Capital Programs, and Camden County.

The County Master Plan makes a distinction between Proposed, Planned and To Be Considered facilities. Facilities "To be Considered" are evaluated by our Complete Streets policy and checklist on a project specific basis. As determined by the project design engineer and safety concerns with the lack of cartway width, there is not sufficient room to allow for a bike facility on this stretch of Church Rd.

Thank you for your support of this project. Gloucester County is committed to include bicycle improvements whenever possible as part of our improvement projects. The County's project for the Board's action is limited to Fries Mill Road, County Route 655 as to the County's authority. The proposed bike lanes will provide the link to Delsea Drive; however, it will not include the designation of the State Highway for formal bike lanes as part of the project, as the authority lies with the New Jersey Department of Transportation. **Response:** Thank you for your comment. Your comment was forwarded to the DVRPC Board and DVRPC Office of Environmental Planning.

DVRPC recognizes the importance of maintaining open space in a natural state for wildlife and conservation. While our potential role in determining the use of this municipal parcel is limited, we recommend you contact Sellersville Borough to get a better understanding of why there may be a need for additional active recreation facilities (assuming the parcel lies within the borough). In addition, the <a href="Bucks County-Planning Commission">Bucks County-Planning Commission</a> is a valuable resource. They can be reached at <a href="bcpc@buckscounty.org">bcpc@buckscounty.org</a> and their Director of Open Space Programs is John Ives. Thirdly, both the <a href="Heritage Conservancy">Heritage Conservancy</a> and <a href="Matural Lands">Natural Lands</a> work throughout the region to preserve open space, and they may have some ideas/thoughts on how to maintain the parcel in a natural state. Finally, Sellersville or the surrounding communities may have Environmental Advisory Councils that could offer assistance.
