

MEETING HIGHLIGHTS

10AM, Friday, January 17th, 2007

Coffee was available at 9:30AM, and a light lunch was served following the meeting. Delaware Valley Regional Planning Commission 8th Floor—Main Conference Room 190 North Independence Mall West, Philadelphia, PA 19106

1. Call to order

Co-Chair Don Shanis of DVRPC called the meeting to order (with co-chair Sharon Daboin arriving subsequently). All Task Force members were recognized, new attendees were welcomed, and the October 27th, 2006 meeting notes (which were emailed to the committee members) were approved by the committee.

2. **DVRPC Freight Studies**

Ted Dahlburg presented an introduction to the Highway Railroad Grade Crossing Management System study being undertaken by DVRPC. This project will lead to a complete inventory of grade crossings in Southeast Pennsylvania, and a highly improved GIS layer for freight and passenger rail lines. Activities are being closely coordinated with PennDOT District 6-0, SEPTA, and others.

Wall-sized maps of the region's rail lines were displayed at the front of the room. Task Force members were asked to review the maps at the conclusion of the meeting and to note and mark changes.

Walker Allen presented the draft recommendations to the NHS Connector Evaluation Study. Draft recommendations were also circulated and Task Force members were asked to review and comment by January 26, 2007.

The recommendations are divided up into 3 sections: Administrative, Suggested Projects, and Implementation/Next Steps. Many of the recommendations result from field views held in conjunction with Freight For A Day, and they will form an important part of the final NHS Connector report.

3. Revisions to the Destination 2030 Long Range Plan

Mike Boyer of the DVRPC staff presented necessary revisions of the 2030 Long Range Plan. The Financial aspect of the Long Range Plan must comply with SAFETEA-LU requirements by July, 2007. Mr. Boyer discussed draft revenues and expenditures and the implications for the set of major transportation projects included in the Plan. Mr. Boyer indicated the Goods Movement Task Force will be integrally involved in the development of the 2035 long range plan.

4. Navy Yard Access Road Project

Mike Noonan presented a progress report of this project in South Philadelphia. Mr. Noonan, a civil engineer, has been with DMJM Harris for 9 years.

Mr. Noonan displayed the two temporary roads which are scheduled to be finished in time for the anticipated opening of the Seafood Terminal in January 2009. He also presented the alignment for the permanent access road which they currently believe will cost \$60-70 million and for which funding has yet to be identified.

Staff will continue to keep the Task Force up-to-date on this project and a presentation about the design of the new Food Distribution Center is scheduled for the April 18 meeting.

5. **Keystone Corridor Clearance Evaluation and Potential Truck Diversion Study** Matt Hurley presented an overview of the Keystone Corridor Clearance Evaluation Study. Mr. Hurley is in DMJM Harris' Transit Rail Department.

The study identifies the feasibility and cost-benefit for obtaining double stack vertical clearance along the Keystone Corridor from Philadelphia to Harrisburg. The major problem areas for clearances in the DVRPC region are in West Philadelphia around the intersection of Belmont and Girard Avenue, and in Montgomery County where the transit stations and historic buildings present a lot of problems. The cost benefit analysis showed less than 2 dollars of benefit for every one dollar spent. Further studies were recommenced to look at alternate routes that avoid some of the major problem areas.

6. Coalition for America's Gateways and Trade Corridors

Adrienne Gregory, Associate, provided an overview of the Coalition for America's Gateways and Trade Corridors. Ms. Gregory discussed the Coalition's leadership on freight issues, key policy positions, major ongoing and upcoming initiatives, and membership opportunities. The Coalition is doing a lot of important work in Washington to inform members of Congress, especially new ones, about the importance of freight and freight transportation corridors.
