DOWNTOWN DELIVERY

Symposium III

Summary of Event

Held in the DVRPC conference room on July 12th, 2017, the Downtown Delivery Symposium III brought together a diverse group of stakeholders from the Greater Philadelphia region to consider issues surrounding the movement of goods to and from businesses and residential locations. The Symposium was a collaboration between the DVRPC freight advisory committee, the Delaware Valley Goods Movement Task Force and the DVRPC Office of Smart Growth.

With a diverse group of speakers, the event delved into the unique challenges of deliveries in small urban settings, the operations of beer distribution, the experiences of dealing with these issues in West Chester, and a discussion on how this region can better accommodate these activities.

The event drew close to 65 attendees, to talk about the growing importance and complexity of urban freight and urban goods movement in smaller urban environments. AICP credits will be available for those in attendance. All presentations given at the symposium are available on the Freight and Aviation page of the DVRPC website.

Introduction

Barry Seymour, co-chair of the DVGMTF and Executive Director of DVRPC kicked off the symposium with welcoming statements and all attendees were invited to introduce themselves and their affiliation.

Michael Ruane of DVRPC provided an overview of the Downtown Delivery Symposium series along with an introduction to the day's focus on accommodating deliveries in small urban settings. Mr. Ruane introduced the agenda for the meeting and provided introductions of the three guest panelists: Mr. Chris Lamm of Cambridge Systematics, Mr. Gerry Dougherty of Gretz Beer Company, and Mr. Malcolm Johnstone of West Chester Business Improvement District.

Freight and Deliveries in Smaller-Scale Urban Environments: Challenges

Chris Lamm a Senior Associate and New York-New Jersey Leader of Freight Planning at Cambridge Systematics provided an overview of small urban environments, trends influencing urban freight deliveries, and conflicts or issues that may exist in urban environments. Mr. Lamm highlighted the shifting supply chain in response to the boom in e-commerce activity that is driving more trips not only to retail locations but also residential locations.

Mr. Lamm also provided an overview of some of the common conflicts and issues that are seen in both large and small urban environments. Issues such as street geometry, curb space capacity, noise and emission are common across all environments. In smaller environments additional issues related to varying rules and mismatches between carrier equipment and “exception” locations can create issues for efficient deliveries. In addition, local government capacity to engage stakeholders is often limited.

Private Sector Perspective: Beer Deliveries by Gretz Beer Company

Gerry Dougherty, Vice President and General Manager of Gretz Beer Company in Hatfield Pennsylvania provided an interesting overview of the company’s operations and some of the unique considerations it must make in urban environments. Mr. Dougherty highlighted the company’s facility in Hatfield and discussed the types of trucks and equipment they use for deliveries. His presentation offered a unique look into the process of scheduling deliveries, routing deliveries, and also the planning that goes into optimizing each stop based on access type and duration of availability of the receiver.

Mr. Dougherty reached out the attendees for feedback on several topics in order to further the discussion on how a private company might better frame the discussion for the public around freight deliveries. He touched on a variety of topics including how drivers respond to traffic and detours and the gaps that currently exist in that process. Mr. Dougherty also highlighted the importance of the receiver’s operation as a factor for when deliveries can be made and it is their schedule that often dictates when trucks must arrive.

Public Sector Perspective: West Chester Business Improvement District

Malcolm Johnstone, Executive Director of West Chester Business Improvement District provided a local look at some of the issues his community is dealing with as they see a revitalization of downtown activity. Beyond deliveries West Chester is seeing a growth rate that is driving up demand for short-term parking and stopping space on many streets. Mr. Johnstone highlighted the case of Gay Street which is home to approximately two dozen bars and restaurants.

Mr. Johnstone discussed some of the existing conflicts that exist on the two-lane road with parking cut-outs. He provided some potential improvements and discussed a case study in Santa Barbara where the street redesign allocated additional space to both pedestrians and trucks. The use of curb space for deliveries pushed short-term parking to adjacent lots but improved the quality of the street front and limited disruption of traffic by delivery vehicles. Mr. Johnstone fielded several questions related to accommodating freight deliveries including concerns about handling larger vehicles on tight streets.

Open Discussion on Accommodating Urban Deliveries in the Delaware Valley

Chris Lamm set the stage for an open discussion on how the region can better accommodate deliveries with a short overview of best practices from around the world. These best practices focus on designing places and streets, managing parking and loading zones, and promoting safe and efficient logistics.

The discussion was turned over to the audience for questions and additional dialog with the panel on the issues raised through the meeting. The conversation started with an inquiry on drones and what role the panelist see these playing in the future. The panel seemed to feel that it was a probability but they could not speak to how they see it playing out in an urban environment. The panel also addressed a need for additional loading system/capacity in older urban environments that are seeing new growth.

The panel was asked about best practices documenting consideration for freight in bike and pedestrian planning efforts or heavy bike/pedestrian environments. None were known to the panelists.

The topic of autonomous vehicles was raised as it relates to downtown deliveries. The panel responses suggest that the most likely starting point for automation remains the long haul moves rather than local deliveries. Gerry identified the hand-off to last mile as being critical and that this leg would likely be handled by people especially as some products, like beer, are heavy and need special handling.

There were several inquiries about coordinated deliveries and it was offered that perhaps a delivery concierge of sorts could be used to help schedule deliveries. The panel also offered the idea of consolidation of deliveries from individual carriers to multiple receivers. The opportunity to consolidate deliveries outside downtowns was also raised but a concern about loss of control of a customer's product makes this even more complicated and less feasible.

Following some closing remarks the panelists were thanked for the contribution to the symposium and attendees were invited to stay for lunch and additional discussion on freight issues.
