QUARTERLY MEETING HIGHLIGHTS

10 AM | July 20, 2022 Zoom Meeting

1. Call to Order

Barry Seymour of DVRPC called the quarterly freight advisory committee meeting to order. Mr. Seymour welcomed all task force members and friends and encouraged everyone to unmute and introduce themselves. He also shared that he will be retiring as the Executive Director of DVRPC and will stay in the role until a new Executive Directory is selected.

2. NYMTC Clean Freight Corridors Study

Gerry Bogacz, New York Metropolitan Transportation Council (NYMTC), presented in collaboration with the CALSTART consulting team on the Clean Freight Corridor Study. This project came from a recommendation in NYMTC's 2045 Long Range Plan and it evaluated the entire MAP Forum region with the goal of advancing high-efficiency, low-emission alternative transportation technologies in the region's freight fleet.

Gerry discussed their approach for the study which included analyzing an inventory of existing infrastructure, reviewing clean technology use in the region's corridors, identifying gaps between needed and existing infrastructure, and using freight travel trends and forecasts as a benchmark to assess growth. The study analyzed corridor preparedness for four major clean fuel types (electric, hydrogen, compressed natural gas, and liquified natural gas) and their associated vehicles operating on the region's corridors. The final recommended corridor designations evaluated both readiness and need along major corridors, and seven corridors were recommended as top priority.

3. New Jersey Station Planning Commission Warehouse Siting Guidance

Matt Blake, AICP, PP, The Office of Planning Advocacy, shared an overview of the Commission's recently released Warehouse Siting Guidance. This guidance is directed at municipalities and aims to facilitate a proactive approach by providing municipal factors to consider when developing or updating a Master Plan. It also encourages a regional approach to planning, siting, and facilitating logistics facilities.

Matt briefly reviewed the main sections of the Warehouse Guidance. The guidance emphasizes the need for municipalities to be proactive when considering future warehouse development in the New Jersey region as well as the need to better understand the type of facilities based on their position in the supply chain and relative impacts on municipalities. An importance was also placed on social and environmental justice, and the guidance recommends barriers to curb noise and air pollution that protect residents, adopting community benefits agreements, fostering more community involvement in the siting process, and "good neighbor" policies.

4. Pennsylvania Low Bridge Information System

Ryan McNary, Pennsylvania Department of Transportation, shared an update on Pennsylvania's Low Bridge Information using 511PA (<u>www.511pa.com</u>) and the new traveler information services available via mobile app. He highlighted new features of the product and the progress in the development of this tool. A new data layer now includes locations for all bridges under legal height (<13'6") on state roads, and the mobile app's ability to share this information as an alert that can be heard by motorists in the app's drive mode.

PennDOT's research showed that low bridge crashes are not exclusively a Pennsylvania occurrence and many have been attributed to rental trucks. As a result, rental drivers are a key group at which they are looking to target and share this new app and features. The advertising campaign for the low bridge feature on 511PA began earlier this year and they have seen an uptick in the number of 511PA users that turn on the low bridge notifications. PennDOT is continuing to look into ways to expand their bridge data and application function to include a bridge search along a specified route.

5. Two-minute Reports

The following Task Force and Subcommittee chairs and Task Force members provided updates on the activities of their companies and agencies:

Sean Greene DVRPC

Announced that the window to apply for the Railroad Crossing Elimination Grant Program, funded through the IIJA, will be open until October 4th, 2022, and the DVRPC is available and willing to help any interested organizations with the application process. This particular funding pertains to projects involving railroad crossing elimination only; projects involving railway bridges are not included. Glenn McNichol

Shared a video resource (<u>www.c-span.org/video/?521730-1/transportation-secretary-testifies-infrastructure-law</u>) that shows the recent US Secretary of Transportation report on the state of transportation infrastructure and related topics. He mentioned that the video has timestamps to help viewers navigate to the topic of their choice.

Todd Evans Mount Laurel Fire Department

Raised a question to the committee about truck trips from the port to their first destination. He is looking for more information on any potential exemptions, weight limits, special hazards, shipping requirements, and or anything else pertinent to first responders who come upon overturned, crashed, on fire containers on the roadways. Steve ChiaramonteWSP

Announced that NJDOT is in the midst of creating their next statewide freight plan and that they expect to have their draft existing conditions content out for their stakeholders by next month.

Michael RimerPennsylvania Department of Transportation

Announced that the State's final Long-Range Transportation Plan is now available online (<u>www.penndot.pa.gov/ProjectAndPrograms/Planning/Pages/default.aspx</u>). He also shared that because of the Bipartisan Infrastructure Law and its requirements, the Statewide Freight Plan is gaining attention and that it should be completed in early November 2022.

Kristen Scudder DVRPC

Announced that a new employee, Dan Farina, would be joining her team in the Freight Program at DVRPC. She also shared that the PA 2022 Rail Freight grant programs will be accepting applications in early August 2022. The grant program has been recently transitioned to the new eGrants Public Portal Interface for the 2022 grant application process. A Teams web-based training will be available prior to the opening of the application window and PennDOT staff will be available to assist with any questions.

Amanda Rutherford...... MARAD/ USDOT

Announced that she is available for any questions about USDOT grants and shared that funding is available for bridges and advanced technologies at this time. Additionally, she shared that the ATTAIN grants are available and funds are earmarked for advanced communication systems to convey information about truck charging facility availability.
