### Welcome and Meeting Overview

## Presentations

**Return on Environment**... Patty Elkis, Director of Planning, DVRPC

Patty Elkis presented on the DVRPC's *Return on Environment* report, giving background on the study, the concepts detailed in the report, and current ways people can engage with this ongoing effort.

Water Infrastructure in Philadelphia... Chris Anderson, Watersheds Program Manager, Philadelphia Water Department

Chris Anderson presented on the City of Philadelphia's water initiatives and their incorporation of greening, public outreach, and community inclusion in their programs. This included highlighting the current developments of the Water Department's projects and detailing the outlook for future progress in greening.

#### ROE: Economics and Greening... John Rogers, Principal, Keystone Conservation Trust

John Rogers presented on the Keystone Conservation Trust's concurrent and ongoing work off of DVRPC's *Return on Environment* report. This presentation detailed the importance of communicating the economic value of green space and how this value can be leveraged to change policies and programs.

A panel discussion was facilitated by Shoshana Akins. Attendees asked questions about specific projects within the panelists' organizations and general thoughts on the economics of greening.
