Advocacy

Peer Support is information or support from another person who has had similar experiences.

This can be individudual peer support or group run peer support where people with disabilities plan and run groups with assistance from staff at LRI



Skills Training

The Independent Living Skills Training Program offers classes on basic skills such as Money Management, Managing Your Personal Assistant, Health, Wellness, and Nutrition, Consumer Rights and Responsibilities and How to Use Public Transportation. The classes also offer Consumers the opportunity to learn from and share with other Consumers.



Youth Transition

Youth Services ensures a successful transition of youth with disabilities into the workplace and adulthood. LRI does this through mentorship, peer support, and skills training.



NURSING Home Transition

Ms. Melvina McSpadden is a fighter!

After becoming disabled in 2016, Melvina resided in a nursing facility but knew right away that she wanted the freedom to live in the community in a setting of her choice.

LRI's Housing Consultant and Nursing Home Transition Coordinator worked closely with Melvina to help her secure affordable, accessible and integrated housing, acquiring a security deposit, purchasing essential household items and connecting her to the necessary auxiliary services needed to maintain her independence.

Melvina's emancipation from the nursing facility took place on September 16,2020




Empower the Community

What's in the air in Camden, NJ?



Camden is overburdened with air pollution...

According to the EPA's National Emissions
Inventory data 2020, the city of Camden is home
to many of the top ten industrial air polluters in
Camden County, including the number one
industrial air pollution source the Covanta trash
incinerator in South Camden. Other industrial
sources of air pollution include:

- The Sapphire natural gas power plant.
- The Camden County Sewage Treatment Plant
- Two Cement Factories
- Several scrap operations
- The South Jersey Port
- Metal smelting operations

Camden, New Jersey is the third most polluted school county in the US



Camden is overburdened with air pollution...

Camden is also home to multiple sources of mobile air pollution from highways, trucking operations between industrial sites and the port, and even diesel fumes from the New Jersey Riverline Light Rail system.



Camden is overburdened with air pollution...

Other factors that exacerbate air quality in Camden include:

- Large amount of impervious surfaces
- Lacking in tree canopy

Together these factors create heat islands that exacerbate already poor air quality conditions

This map displays impervious surfaces (purple), tree canopy (green), high traffic areas (red lines).

Camden residents are almost 5 times more likely than your average NJ state resident to visit the emergency room for an asthma attack.


3rd Worst

Out of the New Jersey Department of Environmental Protections 15 Particulate Matter 2.5 (PM2.5) monitoring sites across New Jersey, Camden's site had the highest average levels of PM2.5 of any site, 9.17 µg/m. A recent Harvard study has found that even a very small increase in PM2.5 pollution in the air was enough to cause a 15% increase in death from COVID-19.

What is being done about it?

New NJ State **Environmental Justice Cumulative Impact Bill S232**

What is this new bill? An EJ holy grail?!

- It is the first of its kind in the country.

 (lawmakers have introduced the environmental justice bill every year since 2008, but the legislation always succumbed to industry opposition.)
- It allows the state DEP to deny permits for power plants, incinerators, landfills, large recycling facilities and sewage treatment plants in certain minority and impoverished neighborhoods if the projects pose health and environmental risks in conjunction with the threats those communities already face.
- Rules still need to be written for how this bill will be implemented...

How a long-stalled 'holy grail' environmental justice bill found its moment in New Jersey





Build capacity of community members to fully engage and participate - even during a pandemic

- Park access and comprehensive planning processes were underway as the pandemic took hold
- Rather than pushing forward as if times were normal, Tuolumne River Trust surveyed and spoke with community residents about their ability and capacity to participate in virtual planning
- Surveys revealed that people had computer/tablet access, but needed to develop skills/knowledge to use the internet & connect virtually

- Hosted a virtual workshop focused on how city departments can work together to meaningfully and authentically engage with the community members they are trying to serve.
- Living Streets Alliance then invited project
 managers from the city and an engineering
 firm on a bike ride with neighbors from Pueblo
 Gardens to discuss a potential Prop 407
 greenway project
- Shift Power Over




Safe Routes for Youth
