 - Topic: Safety Data
 - Action: Analyze data about driver behavior/speeds during pandemic by comparing numbers of citations in areas with automated enforcement cameras.
 - Update: Completed analysis comparing Philly speeding and automated enforcement data to DC, an area with a much more robust automated enforcement program.




Total KSI - Regional Trend (by person), 2016-2020








Action Item Development Groups


RSTF Ambassador Program


