## **Speakers' Biographies**

### **Molly Riordan**

Molly Riordan is the Interim Procurement Manager and Special Projects Coordinator at Common Market Philadelphia. Her work spans the organization, working with growers, customers, and food system stakeholders to scale our food system sustainably and safely. Molly earned a Masters in Regional Planning with a focus on Urban-Rural Economic Development, and she sees scalability, land preservation and intelligent infrastructure management as the keys to growing rural wealth through greater marketability of locally produced foods.

### **Deb Bentzel**

Deb Bentzel serves as Senior Associate to The Food Trust's Consulting Team, with a focus on farm to school, farm to preschool, and other local food initiatives and systems projects. She also acts as the Mid-Atlantic Regional Coordinator for the National Farm to School Network, providing training and technical assistance to schools and childcare centers, suppliers and farmers, and other groups interested in implementing or enhancing farm to school practices in the region's six states and Washington, DC. In 2007, as part of the Pennsylvania Fresh Food Financing Initiative, Lance began developing methods for identifying communities with limited access to healthy food retail, eventually leading to a nationwide geospatial model for understanding healthy food access – TRF’s Limited Supermarket Access (LSA) analysis. His current research includes a geospatial model of regional food supply chains, illustrating the potential economic connectivity between a region’s food producers and processors.

Mr. Loethen holds an M.A. in Urban and Regional Planning from Virginia Commonwealth University and a B.S. in Economics from the University of Kansas.
