

Study Advisory Committee Meeting June 5, 2008 1:00 pm – 3:00 pm

I. Introductions

The Project team from DVRPC introduced themselves and their areas of expertise including comprehensive planning, GIS, environmental justice, economic development, freight and transportation and environmental planning.

II. Scope of Work Presentation

Alison Hastings, Project Manager, presented an overview of DVRPC's work, the reason for the organization's interest in food systems, and the scope of work for this project.

The Food System Study will look at a 70 county region within 100 miles of the City of Philadelphia and collect data to evaluate the region's food needs, assess agricultural resources, estimate transportation efficiency and plan for increased local production amidst rising food and energy costs.

The first part of the study, to be completed this summer, is a Policy Network Analysis that will interview key food and farming stakeholders and start to figure out strengths, weaknesses, opportunities and challenges in the food system.

III.Small Group Discussion

The participants were randomly assigned to 4 small groups, led by Project Team members, to brainstorm the content, process and possible contacts for forthcoming food system interviews.

They were asked to think about three questions:

- 1. What do we ask?: participants came up with questions for a particular interview group (i.e., farmers, processors, distributors, retailers, policymakers, non-profits, suppliers, etc). There was a vote for the three most important questions that was reported back to the full group.
- 2. How do we ask?: brainstorm of the best ways to contact different groups (email, phone, inperson, etc)
- 3. Who do we ask?: each person had to come up with five contact that should be interviewed

IV. Next Steps

DVRPC will begin to conduct the surveys, collect literature for a literature review, organize field trips (open to SAC members to attend), and develop a FY10 Scope of work.
